# Appendix 1

## List and categorisation of sites in the portfolio

The appendix lists all sites to which this strategy will apply. They have been categorised using elements of the *London Plan* convention, tweaked to ensure that they reflect recognised characteristics for Bromley. The categorisations are as follows:

- *Regional Park*: Characterised in Bromley as of national status/destination value
- *Metropolitan Park*: Characterised in Bromley by being a country park, likely an SSSI.
- *District Park (Recreation)*: Characterised in Bromley by generally an urban location with significant horticultural, cultural or historic assets (which may also be in the curtilage of an historic building) where traditional park features predominate above sports activities.
- *Local Park (Recreation)*: Characterised in Bromley by a lack of significant horticultural features, historical context or dominant activity, but nevertheless important open space.
- *District Park (Sporting)*: Characterised in Bromley where **organised** sporting activities, playgrounds, large areas of mainly flat close grown grass or events predominate above horticultural features or casual sports.
- *Local Park (Sporting)*: Characterised in Bromley where **casual** sporting activities, playgrounds, large areas of mainly flat close mown grass or events predominate above horticultural features.
- *Heathland, Meadow or Woodland*: In Bromley these sites may have a statutory designation (e.g. SSSI) or a non statutory designation (e.g. SINC) and consist of predominantly rural heath, meadow or woodland and not principally maintained by *idverde* Grounds Maintenance team.
- *Cemetery*: Active burial grounds that are not within a churchyard that are principally maintained by the Grounds Maintenance team.
- *Closed Churchyard*: A churchyard belonging to a parish or cathedral church of the Church of England and is no longer used for burial purposes. The Council retains some grounds maintenance responsibilities at these sites.
- *Allotment*: Plots of land made available for the individual growing of food or plants. These sites are managed and overseen in partnership between the Council, *idverde* and the respective allotment associations.

Each site is given its own number ('**Code**') which match the numbering on the map in **Section 2.2**. along with its address, categorisation, and any relevant further information. These categorisations relate to the primary function that the site serves but does not negate any other functions that it may provide.

Each site is given by its official name as known to the Council which may differ to what they are known locally. Some areas may also have been subsumed into the larger site of which they are part, however it is hoped that this list captures the essence of all Portfolio sites as a whole.

# Project proposals and further case studies

### 2.1 Project proposals

Overviews of proposed projects mentioned in the strategy are given in the below table. Please note that all are proposals and subject to the appropriate consent/funding being successfully sought.


## Appendix 4

### Strategic context

This strategy has been designed so that it actively responds to the requirements of both national and regional legislation, whilst also being careful to reflect the specific Bromley context.

#### 4.1 National context

The National Context of this strategy is dictated by central Government's Planning Policies (and how these apply to Open Spaces), and the Council's statutory requirements to biodiversity.



The *Open Spaces Act 1906* requires the Council to hold its open spaces and burial grounds in trust for the benefit of the public, and to maintain them in a good and decent state.

The *National Planning Policy Framework (NPPF)* sets out a framework for preparing plans for local housing and other developments and notes that access to high quality open spaces and opportunities for sport and physical activity is important for community health and well-being. SO1 and SO4 of this strategy look to base recommendations on robust and up-to-date assessments of deficits to open space, sport and recreation facilities as required by this framework. SO3 makes provision for the use of the Portfolio as an asset to community mental and physical health. The NPPF also notes that strategic policies should make sufficient provision for conservation and enhancement of the natural, built and historic environment, in particular so that they manage and mitigate the impacts arising from a changing climate (SO2 in this strategy).

The *Planning Act 2008* and the *Town and Country Planning Act 1990* put into place CIL and Section 106 agreements, from which this strategy could look to retrieve funding for proposed projects with a community benefit.

The *Wildlife and Countryside Act 1981* (as amended by the *Countryside and Rights of Way Act 2000*) requires the Council to have regard to the desirability of conserving the natural beauty and amenity of its countryside, whilst the *National Environment and Rural Communities Act 2006* requires it to have due regard for biodiversity. This strategy has embraced the conservation of flora and fauna of the Open Space portfolio in both the borough’s urban and rural locations.

## 4.2 Regional context

The Regional Context of this strategy is influenced by both how Bromley’s position in Greater London can help it support economic, social and environmental improvements within the region, whilst remaining sensitive to local context and aspirations.



The *Greater London (Parks and Open Spaces Order) 1971* redistributed the ownership and management of certain sites from the Greater London Council to local authorities, some of which contained restrictions as ‘Parks and Open Spaces’ when transferred.

The *London Plan 2020* is a spatial development strategy for Greater London which sets out a framework for how it should develop over the next 20-25 years. It notes that its network of Open Spaces should be enhanced, and that blue and green infrastructure should be planned, designed and managed to achieve multiple benefits:

- The promotion of mental and physical health and well-being (SO3)
- The adaption to the impacts of Climate Change (SO2)
- Supporting landscape and heritage conservation (SO2)
- Learning about the Environment (SO2)

The plan is supportive of many proposals contained within this strategy, including the improvements of recreation facilities, the creation of new habitat and development of SuDS.

The *London Environment Strategy* integrates all aspects of London's environment including specific policies for air quality, green infrastructure, climate change mitigation and adaptation, ambient noise, and the low carbon circular economy. SO2 of this strategy contributes towards the aims of this plan by creating opportunities for the capture of atmospheric carbon, along with helping build resilience to a changing climate.

The strategy also confirms London as the world's first National Park City whereby:

- It will become greener in the long-term future than it is today.
- People and nature will be better connected with children benefiting from exploring, playing and learning about the rich wildlife on offer from the city.
- Its core network of Open Spaces is protected and over half its geographical area will be designated as such.
- All will enjoy high quality open spaces via an active transport network.

Bromley as the largest borough with over half its land area as 'Greenspace' of some description, is well placed to support this initiative and has aligned the key policy ideals of this strategy (Improving Environmental and Climatic Sustainability, Community Assets and Local Transport to and from Open Spaces) to it.

The *All London Green Grid (ALGG)* is a policy framework aimed at promoting a network of green and blue spaces that are designed and managed to provide a range of recreation, health and environmental benefits. It has developed eleven area frameworks, of which Bromley is included within three. This strategy has aimed to identify key strategic locations within the Open Space Portfolio that are included within these frameworks and produce improvements to them:

- **South East London Green Chain Plus:** The strategy supports opportunities in this area including the creation of a connected park system along the Ravensbourne and Pool Rivers such as via the reinstatement of natural channel (the Glassmill Lane Reservoir in SO2) and the extension of the Green Chain Walk (Active Transport in SO3).
- **River Cray and Southern Marshes:** The strategy supports opportunities for linkages into the borough via the River Cray Greenway (e.g., the restoration of Priory Gardens in SO4 which is the river source)
- **London Downlands:** The strategy supports key opportunities within this area including the promotion of biodiversity within Darwin's landscape (the educational policy outlined in SO2), and the development of Crystal Palace Park to Regional Park Status (the regeneration model in SO1) and the restoration of natural landscapes (the funding of land restoration for the benefit of biodiversity via HLS in SO5)

The *Review of London's Parks and Green Spaces* noted that historic approaches to Open Space management prevent local authorities realising their full range of benefits and suggests diversified solutions via stakeholder and community-based organisations are needed. It also notes that a lack of a robust evidence base via Natural Capital Accounting makes it hard to fully demonstrate this value.

SO1 makes provision for producing such an evidence base to ensure Open Spaces are placed into broader Council environmental, economic, health and goals, whilst also seeking to build the Council's community-based approach to Open Space management.

The *Mayors Transport Strategy* notes how investment in Open Space green infrastructure encourages active transport use and reduces associated health problems of car dependency (SO3)

### 4.3 Local context

The Local policy context of this strategy is influenced by how the Open Space Portfolio can support the regeneration of the borough and in turn lead to improved community, health and wellbeing services, as well as mitigating and adapting to the impacts of a changing climate. The Council's policies influencing this strategy, themselves align to national and regional policies where appropriate.



The *Bromley Local Plan 2019* sets out planning policies, site allocations and land designations borough wide. This strategy corresponds to the commitment given to Open Space within the plan by resisting any inappropriate development to local open spaces, respecting the character of the Green Chain Walk (including enhancement of wildlife habitat), and ensuring the enhancement of sports and recreation facilities where possible, including improvements in areas of identified deficiencies.

The *Bromley Regeneration Strategy 2020-2030* aims to regenerate the borough by building on its built and natural heritage so that it 'continues to represent the best of town and country'. The strategy makes provision to nurture the sustainability of Open Spaces for environmental, financial, wellbeing and carbon reduction benefits. This strategy aligns with four of its identified areas of improvement:

- The improvement of children's play facilities (SO4)
- Bringing vacant portfolios buildings back into use to support growth of the local economy (SO2)
- The Regeneration Plan for Crystal Palace Park (as outlined in SO1 and itself aligning with the *Crystal Palace Regeneration Plan 2020*)
- The Conservation of Scadbury Park Nature Reserve (SO2).

*Making Bromley Even Better* outlines the Council's defining principles to which officer and political structures, including this strategy are expected to align:

- Creating a fantastic place to live and work (the contribution that the Open Space Portfolio makes and will continue to provide to Bromley residents through this strategies realisation)
- Protect, conserve and enhance Bromley's natural and built environment (SO2 of this strategy) whilst enhancing opportunities for leisure, culture and community led services (SO4 of this strategy).
- Allowing residents to prosper in a safe, clean and green environment both today and into the future. (SO1 of this strategy which recognises the importance of partnerships with residents and friends groups to further enhance Open Space).
- Encouraging more sustainable and active forms of travel (SO3 in this strategy)
- The implementation of the Open Spaces Strategy.

The *Bromley Environment and Community Services Portfolio Plan* sets out how the Council will deliver high quality environmental services including the enhancement of Bromley's Open Space Portfolio. This strategy dovetails with several initiatives contained in this plan including the development of the BEECHE centre (SO2), securing external funding to deliver outcomes (SO5) and working in long-term partnerships with local Friends and volunteer communities (SO1).

The *Bromley Biodiversity Plan* translates national and regional policies down to a co-ordinated plan for conserving, protecting and enhancing local Bromley biodiversity and includes:

- The enhancement and restoration of areas with key conservation designations and other biodiverse spaces which the strategy will identify via its rolling programmes of investment.
- The provision of best practice guidance for protecting and enhancing biodiversity in the borough to all stakeholders (educational programme in SO2)
- The involvement of Friends Groups, landowners, volunteer groups and the public in maintaining and managing sites (new governance models as outlined in SO1).
- The sustaining of local species and habitats for future generations (through the realisation of this strategy).

The *Bromley Tree Management Strategy* aims to encourage a varied age structure in the tree stock in the Open Space Portfolio and to prioritise the planting of native and local species where possible.

The tree planting programme contained within SO2 of this strategy adheres to these concepts, aiming to create diverse habitats that deliver the Council's biodiversity and carbon reduction objectives.

Two work streams of the Council's Carbon management team inform this strategy:

- *Bromley Net Zero Action Plan* outlines how the Council will achieve organisational net zero Carbon Emissions by 2029
- The draft *Bromley Net Zero Emissions Strategy*, outlines (subject to approval) the routes to electrifying Council fleet operations, whilst facilitating the growth of the public charging network in the borough. It also aims to support the Council's partners, contractors and staff to switch to zero emissions vehicles.

Elements of SO2 of this strategy have been developed in partnership with the Carbon Management team to be commensurate with and provide support towards the green recovery working group through initiatives such as sourcing investment opportunities for electric vehicle provision, the use of the portfolio where feasible to capture atmospheric carbon and tree planting.

In addition to the Council committing to delivering Net Zero Carbon for its own organisational emissions, it is also working closely with all of its supply chain to collaboratively identify ways to reduce impacts across its services. *Idverde's Sustainability Strategy* launched in 2020 sets out priority aims and objectives for it to continually improve its sustainability performance, primarily around improving strategic decision making to create more sustainable behaviours that trickle down to the local level. SO2 of this strategy contains provision for collaborative working to further build on the recent successes achieved in managing the portfolio via Carbon Neutral Methods.

*The Bromley Infrastructure Delivery Plan* and the *Open Space, Sport and Recreation Assessment* set out what infrastructure is required to both support growth identified in the *Bromley Local Plan* and identify areas where there are deficiencies in quantity and/or accessibility of provision. The principles of SO1 in this strategy build upon these policies via audits that look to ensure there is an enhanced, balanced provision of facilities across the portfolio that meet the needs of stakeholders.

The *Bromley Health and Wellbeing Strategy* sets out how the Council's aims to tackle gaps in health inequalities and achieve a real and measurable improvement in the health and wellbeing of residents through cross-sector working. Via the focus on community health and well-being contained in SO3 this strategy makes provision for initiatives that encourage individuals, families and communities to make a positive choice to lead a healthier lifestyle, such as through exercising in a natural environment or joining a group with a shared interest to improve mental health. The provision to improve grass root sport provision in SO4 for all sectors of the community shall also contribute towards local health and wellbeing.

The *Bromley Loneliness Strategy* takes a borough-wide, all age approach to preventing loneliness in the community by both identifying those individuals at risk and identifying any trigger points that can lead to social isolation. It also aims to support residents on both an individual basis and at a community level. This strategy makes provision (SO3) for the Open Space Portfolio to be used as a

tool to combat social isolation within the community whether through offering people a pleasant environment to meet an individual friend, or in gaining social skills through joining a group with a shared common interest.

*The Guidance for SuDS in Bromley* provides local advice with regards to SuDS and summarises the approval process. This will be adhered to when selecting appropriate sites for the installation of high quality and multi-functional SuDs during the strategy lifetime.

*Individual Site Management Plans* provide a framework to the daily maintenance work carried out by Council, idverde and stakeholder operatives and ensure individual sites specific habitats and characteristic species are recognised. This strategy aims for each site to have its own individual management plan that both sustains biodiversity and ensures they are accessible to all.
