- ii) It includes open air facilities, especially for leisure, recreation, sport, the arts and cultural activities, which serve either the whole or significant parts of London.
- iii) It contains features or landscapes (historic, recreational, biodiverse) of either national or metropolitan value.
- iv) It forms part of a strategic corridor, node or a link in the network of green infrastructure and meets one of the above criteria.

Please note - The material change-of-use of land or engineering and other operations within MOL will be inappropriate unless they maintain the intended openness of the site and do not conflict with the purposes of including land in MOL.

Further information for MOL regulations are given under Policy 50 of The Bromley Local Plan which will be considered when the successful applicant submits their proposal via a Planning application.
